# Affinity Energy and Health and Skin Elements enter into MoU to develop enhanced skin care product range

Affinity Energy and Health Limited (ASX: AEB) (Affinity) and Skin Elements Limited (ASX:SKN) are pleased to announce they have entered into a Memorandum of Understanding (MoU) to pursue the application of Affinity's algae biomass and oils, and cannabis oils for use in Skin Elements' range of natural skin care products.

The MoU represents a significant opportunity for the two companies to collaborate on the development of a new range of algae and cannabidiol (CBD) based products for supply to key global markets and to deliver enhanced product specifications for Skin Elements skin care products.

Affinity is a diversified plant-based health and wellbeing company, with a core operating division dedicated to the development of both algae-based and cannabis-based products for supply to global nutraceutical markets.

Skin Elements is focused on the development, manufacture and sales of natural and organic skin care products — including the market leading Soléo Organics 100% natural and organic sunscreen, PapayaActivs natural therapeutics, Complete Esscience natural skincare and Elizabeth Jane Natural Cosmetics skincare.

Under the MoU, Affinity will respond to outcome requirements and supply its high quality algae and cannabis oil formulations in either discrete or blended forms which Skin Elements will utilise to develop new and innovative product formulations.

### Benefits of Algae and CBD Oils in skincare

Various algae species have well-documented benefits in the formulation of cosmetics and skin care products. Algae are strong sources of anti-oxidants such as carotenoids, high Omega-3 fatty acids, key minerals and vitamins as well as essential proteins. These have been proven to benefit skin hydration, regeneration, moisturisation, protection against UV, as well as improving the appearance of scarring, reducing free radicals and inflammation.

Affinity is currently producing highly concentrated Omega-3 based algae (Schizochytrium and Nannochloropsis, Isochyrsis and Tetralselmis), all of which have been acknowledged and documented to provide skin care benefits.

It is well established that CBDs interact with receptors in the skin called the endocannabinoid system. One key targeted benefit of CBDs in skin care is high antioxidant protection to help to fight signs of ageing. CBDs assist in reinvigorating the receptors which interact with your endocannabinoid system targeting increased moisture, improved elasticity and a more youthful appearance overall.

CBDs have also been shown to be an effective way to reduce skin inflammation and blemish-prone skin. One of the omega-6 fatty acids that CBD contains is <a href="mailto:gamma-linolenic acid (GLA)">gamma-linolenic acid (GLA)</a>, which acts as a powerful anti-inflammatory while simultaneously encouraging skin growth and new cell generation. This can help to calm inflammation and irritation on the skin, including acne and some conditions like <a href="mailto:psoriasis">psoriasis</a>, while keeping the skin nourished and moisturized.

There are very few skin care companies in the world offering a combined all natural algae and CBD product. Both Skin Elements and Affinity will now partner to create a unique and beneficial product range which, in conjunction with an effective marketing campaign, could be a major boost for both companies.

#### **About the MoU**

The MoU is a non-binding agreement with an initial timeframe of 12 months and the capacity to extend subject to the agreement of both parties. Affinity will be the exclusive supplier of both algae and CBD oils to SKN. It is intended that the MoU will be formally reviewed at six monthly intervals, but it can also be reviewed and amended at any time by agreement of both parties. Either party may terminate this MoU with the provision of one months notice.

Both parties would also like to advise that the economic impact of the MoU is yet to be determined, with commercial terms and financial arrangements to be negotiated at an appropriate time as product development initiatives progress. Both Skin Elements and Affinity will keep the market informed of such negotiations in due course.
