- The Performance Rights have been issued for nil consideration;
- Each Performance Right carries an entitlement to one ordinary fully-paid share in the Company for each Performance Right vested;
- Vesting only occurs after the end of the Performance Period (30 June 2021) and the number of Performance Rights that vest (if any) will depend on:
  - o an identified Net Debt to EBITDA Ratio for the Company ( $\leq 2.5$  times) at the end of the Performance Period (30 June 2021);
  - o the Company securing refinancing of its Debt Facilities to the satisfaction of the Board (in its absolute discretion) by the end of the Performance Period (30 June 2021); and
  - o total shareholder returns relative to a selected peer group of companies over a period of 3 years from 1 July 2018 to 30 June 2021.
- The holder may exercise a vested Performance Right at any time within 2 years after the vesting date (**Exercise Period**);
