Amcor plc (ASX: AMC) – Admission and Commencement of Official Quotation – Foreign Exempt Listing

Description

Following approval by the Federal Court of Australia on 4 June 2019 of Amcor Limited's scheme of arrangement with its shareholders to create a new holding company, Amcor plc ('AMC'), in order to effect the combination of Amcor Limited and Bemis Company, Inc ('Bemis'), AMC was admitted to the Official List of ASX Limited ('ASX') as an ASX Foreign Exempt Listing today, Tuesday, 4 June 2019.

As an ASX Foreign Exempt Listing, AMC will primarily be regulated by the listing rules of its home exchange (being the New York Stock Exchange (NYSE)) and is exempt from complying with most of ASX's Listing Rules.

Official Quotation of AMC's securities is expected to commence at 10:00am (AEST) on Wednesday, 5 June 2019 initially on a deferred settlement basis.

No funds were raised by AMC in conjunction with its listing on the ASX.
