**COMPLETION OF SECOND TRANCHE OF SHARE PLACEMENT**

We advise that settlement of the second tranche of the share placement announced by Swick Mining Services Ltd (Company) on 20 September 2019 has been completed (Tranche 2 Placement). The Company has issued 30,499,769 ordinary fully paid shares at a subscription price of 23 cents each to institutional and sophisticated investors through Euroz Securities Limited as sole lead manager, for gross proceeds of \$7,014,946.
