# **OVER THE WIRE HOLDINGS LIMITED**

## HALF YEAR RESULTS TO 31 DECEMBER 2021

Over the Wire Holdings Limited (ASX:OTW) ("Over the Wire" or "Company") is pleased to announce its financial results for the half-year ended 31 December 2021 (H1 2022). A summary of the financial results is set out below:

### Business Performance (Recurring)

Recurring revenue grew 31% to \$60.2m for the half. The result demonstrates demand from customers across all four product lines including:

#### Outlook

In December 2021 the Company announced that it had entered a Scheme Implementation Deed (SID) with Aussie Broadband Limited (ASX:ABB) under which it is proposed that Aussie Broadband Limited will acquire 100% of the share capital in OTW. The Scheme meeting was held on 24 February 2022 and OTW shareholders voted in favour of the scheme. The scheme is expected to be implemented following Federal Court approval in March 2022.
