EXTENSION OF NON-RENOUNCEABLE ENTITLEMENT OFFER

Flexiroam Limited (ASX:FRX) (**Flexiroam** or the **Company**) refers to the 1 for 15 non-renounceable entitlement offer at \$0.023 per share to raise up to \$1,012,931 before costs (**Entitlement Offer**) and advises that the closing date for the Entitlement Offer has been extended to Friday, 15 March 2024.
