## Respiri raises \$1.6 million through Additional Placement

Respiri Limited (ASX:RSH; OTCQB:RSHUF)("Respiri" or the "Company"), an eHealth SaaS Company supporting respiratory healthcare management and remote patient monitoring (RPM), is pleased to announce that it has received firm commitments to raise a further \$A1.6 million (the "Placement") from existing sophisticated and professional shareholders. These investors have invested with confidence in Respiri leadership and with the operational progress to date in the USA following completion of their due diligence on the Respiri business strategy and achievements.

Under the terms of the Placement, the Company will issue 53,333,333 new fully paid ordinary shares ("New Shares") at an issue price of \$0.03 per New Share. This issue price represents a discount of 14.3% to the Company's last closing price of \$0.035 on Monday 29 April 2024.

The Company has received the Placement funds in advance and will be converting to equity in the coming weeks.

The funds raised from the placement will be allocated towards financing the final payment(s) for acquiring Access Managed Services LLC (Access) and meeting the working capital needs to expedite the growth of the RPM business in the US.
