ASIC relief

 Speedcast Australia Pty Limited, one of Speedcast's group companies, has been granted further relief from its obligations to report to members and lodge reports by the Australian Securities and Investments Commission (ASIC).

Sydney, Australia, 25 January 2021 – <u>Speedcast International Limited</u> (ASX: SDA), the world's most trusted provider of remote communication and IT solutions, today announced that one of its group companies, Speedcast Australia Pty Limited (**the Company**) has been granted further relief by ASIC from certain reporting obligations under the Corporations Act, following equivalent further relief granted to Speedcast International Limited.

Under the Orders granted by ASIC, the Company does not have to comply with any of the following obligations under Part 2M.3 of the Corporations Act:

- report to members of the Company under section 314 within the time required by section 315;
- send reports to a member of the Company in accordance with a request under subsection 316(1) within the time required by subsection 316(2);
- lodge reports with ASIC under subsection 319(1) within the time required by subsection 319(3).

The relief above applies to the Company's financial year ended on 31 December 2019.

The Orders apply until the earlier of i) 31 May 2021, ii) the date on which a disclosure document is lodged with ASIC in relation to any offer for issue or sale of securities that needs disclosure to investors under Chapter 6D of the Corporations Act, iii) the date that the Company has completed its voluntary financial restructuring under Chapter 11 of the United States Bankruptcy Code, and iv) the date on which the Company has a liquidator appointed to it.
