## Issue of Shares

Sydney, Australia, 24 May 2021 – Splitit Payments Ltd. (ASX:SPT “**Splitit**” or the “**Company**”), a global payment solutions provider, advises that it has issued 431,818 fully paid ordinary shares (“**Shares**”) on exercise of 451,555 unlisted options (“**Options**”) under the Company’s Employee Share Incentive Plan (“**Plan**”) of which:

- 55,263 Shares were issued on exercise of 75,000 Options pursuant to the cashless exercise facility under the Plan; and
- 376,555 Shares were issued on exercise of the same number of Options.

The Company also advises that 75,000 Options issued under the Plan were cancelled due to failure to meet the relevant vesting conditions.

A cleansing statement in respect of the Shares is set out below and an Appendix 2A is enclosed.

### Cleansing Statement

The Company hereby notifies ASX under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (“**Act**”) that:

- a) on 24 May 2021, the Company completed the issue and allotment of 431,818 fully paid ordinary shares;
- b) the Company issued the shares without disclosure under Part 6D.2 of the Act;
- c) the Company provides this notice under section 708A(5)(e) of the Act;
- d) as a disclosing entity, the Company is subject to regular reporting and disclosure obligations;
- e) as at the date of this notice,
  - (i) the Company has complied with the provisions of Chapter 2M and section 674 of the Act as they apply to the Company;
  - (ii) there is no information that has been excluded from a continuous disclosure notice in accordance with the ASX Listing Rules and that investors and their professional advisors would reasonably require for the purpose of making an informed assessment of:
    - A. the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
    - B. the rights and liabilities attaching to the Shares.
