NOTICE UNDER SECTION 708A OF THE CORPORATIONS ACT

This notice is given by 4DS Memory Limited (“Issuer”) under section 708A(5)(e) of the Corporations Act 2001 (“Act”).

The Issuer on 6 September 2021 issued 1,126,400 Shares at an issue price of \$0.042 per share following the exercise of 1,126,400 unlisted options (the “Issued Shares”).
