SECONDARY TRADING NOTICE

This notice is given by Nearmap Ltd ACN 083 702 907 (ASX:NEA) (**Company**) under section 708A(5)(e) of the *Corporations Act 2001*(Cth) (**Corporations Act**).

The Company today issued a total of 357,797 fully paid ordinary shares on conversion of options, of which 218,290 were issued in accordance with ASIC Class Order 14/1000 and therefore do not require cleansing under section 708A(5)(e) of the Corporations Act.
