The maximum consideration for the share issue is \$5.625 million. The number of shares to be issued, which are contingent on Austek achieving EBIT targets, is calculated based on the 5 day VWAP prior to completion and accordingly the final number of shares to be issued may differ to the number estimated in this document. Shares are to be issued in 3 tranches being:

1. Tranche 1 - 651,545 shares issued 20 business days after the release of MGH's results for the year ended 30 June 2024.
2. Tranche 2 - 651,545 shares issued on the 12 month anniversary of Tranche 1.
3. Tranche 3 - 651,545 shares issued on the 24 month anniversary of Tranche 1.
