QUARTERLY ACTIVITIES REPORT

MELBOURNE, AUSTRALIA (31 October 2023): Hexima Limited (ASX:HXL) (**Hexima** or **Company**) a clinical stage biotechnology company, today releases its Appendix 4C and sets out below its quarterly activities report for the quarter ended 30 September 2023.

During the quarter, Hexima continued to focus on exploring opportunities for transactions with third parties which could enhance or enable the potential value of the Company's assets, including its intellectual property and other intangible assets, to be realised. The Board continues to advance this goal of maximising shareholder value through a transaction.

Following the passing of the former Chairman, Professor Jonathan West, the company underwent a restructure of the Board at which time Scott Roberson, Michael Aldridge and Jake Nunn stepped down and Geoffrey Kempler was appointed. Geoffrey Kempler was subsequently elected Chairman of the Board and Phillip Hains was appointed as a Non-Executive Director in September. The current Board comprise Nicole Van Der Weerden, Jason Yap, Phillip Hains and Geoffrey Kempler as Chairman

Financial update

The company closed the quarter with \$2.01m in the bank compared to \$2.19m at the end of the previous quarter.

Net cash used in Operating activities amounted to \$181k for the quarter with year-end compliance costs, including annual report and annual listing fees being among the largest payments.
