AIM Chair Deanne Weir to retire after 14 years

As we made clear in our H1 results released today, we are continuing to deliver improved financial and operational results as we execute our transition strategy, so this now feels like the right time to step down. I will of course remain a passionate supporter and significant shareholder, and I wish John, Tony and the team every continued success. I want to thank the Board, our incredibly committed staff, our customers and shareholders for being on the journey with me."

Al-Media Co-Founder and CEO Tony Abrahams said "Without Deanne there would be no Al-Media. Her early investment, her mentoring and guidance, and her board leadership have all been critical to the development of the business. I am extremely grateful for all that she has done for the business, and for her many years of support."

Incoming Chair John Martin said "On behalf of the Board I want to thank Deanne for everything that she has done for AI-Media. She has been a pleasure to work with, and a driving force in the business. I am looking forward to working with the Board, Tony and the executive team in my new capacity as Chair as we continue to grow the Company and deliver increased shareholder value."
