

The Authorised Representative may be changed from time to time and You will be informed.

"Contract" means this MDA contract.

"Corporations Act" means the Corporations Act 2001 (Cth).

INVESTMENT PROGRAM

1. THE PURPOSE OF THE INVESTMENT PROGRAM

- The Portfolio remains in Your name and is held separately from other Investors so
 this means that You can change your instructions and vary Your Investment as
 You need.
- We are required to report to You on Your Investment, and provide quarterly and yearly reports.
- You can access information concerning Your Investment on-line if You decide to do so.

3. SIGNIFICANT RISKS

- This MDA Contract may **not** be suitable for You if You have provided to Us limited or inaccurate information relating to Your relevant circumstances.
